We now use Blue Host as server. If there's not enough time to switch to GoDaddy, we can pay for one more year and then switch. We just renewed our domain name for 1 year last fall.

Treasurers Reports:

We received a written Treasurer's Report from MaryKay. It indicated that the Fidelity Endowment Account Increased to \$16,873.56. The CC5 Grant checking account was at \$878.69.

The main CC5 checking account rose to \$4,421.88. The report also included a discussion of optional services for accepting credit card payments. (CC5's "ProPay" vs. the "Square") and their relative costs and charges. The Report also indicated that 2019 taxes are in process, but waiting for the February 15 Fidelity statement.
