• Membership Committee (Joan and Neil Barkin)

Joan has been sending thank you notes to donors.

Glenn mentioned that some new donations may have been prompted by January mailings.

Osprey Nest Cam:

Glenn- The cam is up and running, it's very exciting, we are receiving a handful of comments and questions.

Does the light bother them at night? No, uses infrared light at night, not visible to birds or humans.

Maybe we need a *Frequently Asked Questions* section on the web page. Blackwater uses 2 links for questions and answers on their site.

NBC Boston (affiliated with Comcast) is adding the nest cam to its morning weather reports, also featured on-line in the Enterprise and on the radio at 99.7 and other places.

Glenn asked Tom E. about publicity from USF&WS. New Interpretive Services staff Joy is just getting up to speed with everything. Will send her the press release for information.

The actual embedded link is limited to the Friends website. Other places link people to the Friends web page. Everything is recorded so if you see something exciting, make a note of the time/date as we can use clips for still shots and future videos of the seasonal highlights.

Joan Muller said that vacation week activities at WBNERR will be focused on the osprey.

Tom Eagle suggested trying to contact Chronicle TV to do a program. Could focus on the nest cam but also pine barrens, prescribed burns, aerial photos of Child's River restoration.

Katelyn suggested talking to Brad Sweet who works at Mashpee T.V.

Prescribed Burns – Tom Eagle

Training his staff, they are supported by Mass Wildlife

The state is burning in Mashpee Pine Barrens

Looking at areas off of Red Brook, may burn an area near Jehu off Great Oak Road. Weather dependent so schedule is flexible.

Other possible sites Falmouth Rod and Gun and areas in Maine. Need media contacts to send out information about the burns.

Katelyn wanted to schedule a day during school vacation week to build a demonstration "brush pile" near the Great Hay Road entrance, hopefully using AmeriCorps members.

Pollinator Gardens – Mary Kay

There was a unanimous vote to approve the purchase of \$883 worth of plants from . We are ok 'ed to order wholesale from Sylvan Nurseries. NE Wetland plants has a \$250 minimum. Purchased some larger plants this time to increase survival, especially where it is difficult to water. K.C. from Rod and Gun purchased \$250 in plants as well.

Discussion about pick-up when they are ready in Hadley. Tom E. May be available to help with pick-up and delivery. Neil Barkin will be in Hadley last weekend in May and may be able to help with some as well.

Talking with the Tribe to get an idea what plants they want for POH camp this year that have traditional, medicinal or cultural importance.

The Tribe has a greenhouse at the horse farm. Check with Dale/Jason to see if they can pick-up and keep some of the plants until summer. There is a POH meeting on April 20th.

May be able to store some plants in the propagation beds at Falmouth Rod and Gun Club. Could also keep some to overwinter if needed. Below is a list of plants purchased.

AmeriCorps – **Newsletter**, **brochure** Emilie Brush

The Spring Newsletter is almost ready, waiting for osprey cam press release to come out. It includes, Creature Feature: River Otter, a blurb about the Rabbitat brochure, and may include osprey nest repair from January.

Katelyn mentioned a needed nest repair off of Monomoscoy. Katelyn has a couple of people from Natural Resources to help with this nest repair, also Glenn and MK and would welcome others who want to assist. Date: Friday, April 8th.

The plan is to stick to 3 articles and get back to a quarterly publication. Some help is needed with formatting from Glenn/Katelyn. Emilie thinks we should go with the E-newsletter formatting in the future with our new Constant Contact.

She has been meeting with Mary Kay and Katelyn on Wednesdays and the pollinator brochure will be ready soon. She will send it to the Friends for a first look and comments. The focus is Cape Cod specific and how you can make a difference on your property.

Friends Academy at NETC in West Virginia – Mary Kay

This is a five day, all expenses paid workshop for NWR Friends board members. They are accepting applications, running July 25th through July 29th 2022. Good chance to network and learn from other board members. Represent groups with budgets from \$200 to millions of dollars.

Discussion- MK and Nancy have attended in the past. It would be great if Glenn could attend but he isn't sure he is available.

Requested program- Ohio Girl Scout Troop

Group of 10 middle school aged girls will be on Cape July 5 through the 11th and staying in Hyannis. They requested a program/activity to enhance their trip. The Friends group brainstormed lots of ideas from pollinator gardening, seining in the bay, a boat trip, involving the Tribe with an activity like shell fishing, having a BBQ for them afterwards.

The decision was that Emilie will take the lead and contact the group to discuss specifics. She will work with Hannah, the new VSS at Waquoit Bay Reserve, to plan the programming and will incorporate the Friends into their plan.

There was a motion to adjourn and the vote was unanimous.
